Socialism and One World Government

their New World Order under the guise of planetary concerns -- global warming, climate change, or sustainable development. The people of earth (including Americans) are being duped into erecting a global government that will control every aspect of their lives. Globalism is simply the practice of socialism on a global scale.

A New World Community

As we have discovered over the past several weeks, the rise of socialism has been and still is a danger to our Constitution, our moral and religious foundation, our families, our schools, our churches, and our rights and liberty. But socialists have a much bigger prize in mind than the United States. They openly talk of their desire to establish a New World Order, a government that would impose their radical ideals on the people of all nations. Their efforts have been so intense in America because the U.S. is the final roadblock to achieving their goals.

Remember the three *Humanist Manifestos* from Lesson 1? The manifestos (1933, 1973, 2003) reveal the twisted worldview of socialists, that of secular humanism. Their endgame is to break down the independence and sovereignty of all nations and establish a world community. Here are their words.

We deplore the division of humankind on nationalistic grounds. We have reached a turning point in human history where the best option is to transcend the limits of national sovereignty and to move towards the building of a world community.

Humanists look to the development of a system of world law and a world order based upon transnational federal government.

The world community must engage in cooperative planning concerning the use of rapidly depleting resources. Ecological damage, resource depletion, and excessive population must be checked by international concord.

Notice that the impetus for this global community under a transnational government is to combat “ecological damage, resource depletion, and excessive population.” In other words, socialists are building

The Bible and One-World Government

The concept of globalism – one world government – is not new. It has been around since the beginning. After the flood of Noah’s day, the Lord told people to “spread out and fill the earth” (*Gen. 9:1*), but a leader named Nimrod (meaning “rebel”) rallied the people to stay in Babel, rebelling against the Lord’s command. Nimrod led the people to build a tower, a way to reach heaven without God (*11:1-9*). Of course, God confused their languages and forced them to spread out, but it was clear that Satan, using ambitious fallen men, desired world domination in defiance of God.

The Tower of Babel was just the beginning. History is full of examples of expansive empires – Egypt, Assyria, Babylonia, Persia, Greece, Rome, England, and others – all established in the pursuit of wealth and power. That desire is still present. That goal of a one-world government still exists.

The Bible mentions a one-world government in the end times. God revealed it to Nebuchadnezzar in a dream (*Dan. 2*). In that dream, Nebuchadnezzar saw a statue with different metals, all representing the great empires of the earth. Next, “a stone was cut without hands and struck the statue and crushed it” (*v.35*). Then, “the stone that struck the statue became a great mountain that filled the whole earth” (*v.43*). The Lord revealed to Nebuchadnezzar that He would return to earth as a conquering King, and He would establish a one-world government (*Isa. 9:6; Phil. 2:10; Matt. 28:18; Rev. 19:16*).

Not to be outdone, Satan desires to establish his rule on earth as well, one that precedes the kingdom of Christ. When Satan was cast to earth for rebelling against God in heaven (*Isa. 14; Ezek. 28*), he sought

to undermine God's authority by establishing his own. Remember, Satan tempted Jesus by offering Him all the kingdoms of the world (*Luke 4:5-7*). His earthly kingdom will culminate in the end times with one government, one currency (economy), and one religion (*Rev. 13*). Satan's global government will be short-lived, but it will happen, and everything today is moving in that direction.

Globalism Today

Everything is in place now for another global government. However, the New World Order involves a different approach than the Old Order. The old way of global government was for one nation to conquer the rest (i.e., Babylon, Persia, Greece, Rome), spreading its dominion over the earth. This type of global government (an empire) is represented by the single metals in Nebuchadnezzar's dream – gold, silver, bronze, and iron (*Dan. 2:31, 32*).

However, the feet in Nebuchadnezzar's statue, which represent the final earthly "empire," were made of iron and clay, a mixture that is completely different than the others (*v. 33*). The feet represent the New World Order, not one nation dominating the rest but all nations and global entities (i.e., media, banks, businesses, organizations, etc.) working together in a transnational community.

The Old-World narrative of one nation conquering the rest has proven to be extremely difficult and impracticable. Even in modern history, ambitious politicians and military leaders have not been able to fulfill their dreams of global conquest (i.e., Napoleon, Mussolini, Hitler, Tojo, Stalin). Thus, a new strategy has been set in motion, one that is much more subtle yet just as dangerous. Instead of promoting unification by conquest or destruction, this organization has been touted as an effort to achieve world peace or unification by deception. This new transnational community is the United Nations.

The United Nations

While the terrifying images of World War I were still fresh on the minds of world leaders, President Woodrow Wilson pitched a plan to secure world peace. The plan was known as *Wilson's Fourteen Points*.

On January 8, 1918, he presented the plan to Congress to make the world "fit and safe to live in. All the peoples of the world are partners in this interest," said Wilson, "and the only program for peace is our program." Wilson listed thirteen steps to achieve this longed-for peace, but he saved his Trojan Horse for last. "A general association of nations must be formed..." (Article XIV).

Wilson's document established the League of Nations with 42 founding members. However, according to the Constitution, the Senate must approve all treaties. Behind the leadership of Henry Cabot Lodge, the Senate rejected Wilson's Fourteenth Point and the U.S. did not participate in the League of Nations, citing infringements on national sovereignty and independence. Without the leadership of the United States, Wilson's League of Nations was destined to fail. However, after the scare of World War II and the impending threat of the spread of Communism (Cold War), the League of Nations was replaced with the United Nations, with the U.S. leading the way.

The United Nations was officially established on October 24, 1945, in San Francisco, when representatives of 50 nations signed the U.N. Charter. President Harry Truman represented the United States. The U.S. not only was the first nation to join the new global government, but it also volunteered to be the host nation, building the U.N. headquarters in New York City. Today, 193 of the 195 eligible nations are members of the U.N. Only Vatican City (sovereignty of the Pope) and the Palestinian Liberation Organization (PLO) have refused membership.

According to its website, "The U.N. can take action on issues confronting humanity, such as peace and security, climate change, sustainable development, human rights, humanitarian and health emergencies, gender equality, governance, food production, and more." Global government is here.

Though the U.N. is touted as a peace-keeping organization and an agent of humanitarianism, it has been discovered that the U.N. Charter was written by Alger Hiss, a Soviet spy who was working for Joseph

Stalin in the 1930s. (*Shadows of Power*, James Perloff). Thus, the Charter was written by the Communists to favor Communist or globalist activity. The United Nations is not a friend to the United States.

The Establishment

Furthermore, the formation and promotion of the United Nations was spearheaded by a secretive group of wealthy bankers and businessmen known as the Money Trust or the Establishment, with powerful titans like J.P. Morgan, John D. Rockefeller, Andrew Carnegie, and Henry Ford (*Shadows of Power*, James Perloff). These American monopolists invested their money in causes and organizations that undermined the Constitution, sacrificed American independence, and forfeited national sovereignty to global organizations.

For example, after the failure to involve the U.S. in the League of Nations in 1919, the Establishment launched two influential agencies – the Committee for Public Information (CPI) and the Council on Foreign Relations (CFR). The CPI is a propaganda machine whose sole purpose was to convince the American people of the need for global governance. To achieve its goal, the Establishment bought the 25 most influential newspapers in the country. With the media in their pocket, they began a campaign to bombard the public with globalist propaganda.

The CFR is the face of the Establishment. Located in the Pratt House in New York City (and now in D.C.), the purpose of the CFR is to place globalists in influential positions (government, media, academia, business, etc.) to advance its agenda, that of creating a one world government. With its members in key positions (Democrats and Republicans), the CFR can steer American foreign policy to be favorable to its global agenda. The CFR's logo displays a man on a white horse (*Rev. 6:2*), hailing victory with the Latin word *ubique* (meaning “everywhere”), a common inscription on Roman coins.

The Establishment (CFR) is responsible for many of the departures from the Constitution, as well as the modern movements to destroy America from within. The CFR was behind the formation of the Federal

Reserve (which now controls our money supply), the implementation of the income tax, President Wilson's League of Nations, the Stock Market Crash of 1929 and the Great Depression, the Presidency of Franklin Roosevelt who gave us the New Deal (government welfare programs), the formation of the United Nations (Rockefeller donated the property for the U.N. headquarters), the Cold War of President Harry Truman, and much more. Today, the Establishment is known as the Deep State.

While these globalists have used American money, American clout, and the American military to advance their global agenda, they have also set pieces in place around the world. Every major nation has a central bank, like the U.S. Federal Reserve, as well as a CFR-type organization that controls national leaders. These regional banks report to and are controlled by the World Bank and the International Monetary Fund (IMF), which are poised to present a global currency. Furthermore, the globalist leaders of each nation meet once a year at the Bilderberg Conference, to discuss the necessary steps to construct their New World Order.

Meanwhile, one of the problems of global government is that each nation has its distinct laws, leadership, economy, and infrastructure. To overcome these obstacles, globalists have moved to create regional organizations that work to blend the many into one. The European Union (1993) is a good example. The EU's headquarters is in Brussels (shaped like the Tower of Babel). Representatives from all member nations collaborate to dismantle local sovereignty and harmonize their laws, values, economies, and infrastructure. Currently, there are no borders in Europe (people are free to move from place to place) and they use one currency (Euro).

Recently, Britain realized what was happening to their country and seceded from the EU (called “Brexit”). In the last twenty years, globalists have moved to establish a North American Union (NAU), like the EU, with no borders and one currency (Amero), working to harmonize the U.S. with Mexico and Canada. The infamous North American Free Trade Agreement (NAFTA) was part of this regional plan.

The first step in regional governance is to blend the economies, which is the goal of NAFTA. Other globalist alliances include the Trilateral Commission (combining the U.S. with Europe and Japan after WW2), the North Atlantic Treaty Organization (NATO), the Southeast Asia Treaty Organization (SEATO), and the Warsaw Pact which were all Cold War coalitions.

None of these globalist entities care for the well-being of nations. Rather they are simply cogs in the machine that is moving the world closer to the New World Order. Joseph Stalin wrote, “Divide the world into regional groups as a transitional stage to world government. Populations will more readily abandon their national loyalty to a vague regional loyalty than they will be for a world authority. Later the regions can be brought together all the way into a single world dictatorship.”

The Ten Planks of Globalism

1. Gain control over nations by lending them money and reduce all currencies to one (easily manipulated).
2. Influence leaders to surrender national sovereignty through entangling alliances and coalitions.
3. Level the nations economically through global redistribution of wealth (foreign aid, free trade, etc.).
4. Establish a bureaucratic world-governing force that makes laws, court decisions, and regulations for all.
5. Manufacture global catastrophes to provoke fear. Then offer “security” in exchange for control and policing.
6. Indoctrinate with propaganda and promote world citizenship over national interests and values.
7. Encourage open borders to allow a free flow of immigrants, blending all nations, erasing distinctions.

8. Convince people to sacrifice individual rights and liberties for the good of the collective.
9. Blend all religions into co-existent worship of the State and of nature or the environment.
10. Keep all people disarmed, dependent, easily traceable, entertained (distracted), and ignorant.

The Dangers of Globalism

If men were perfect and true equality and peace could be achieved, then global government would be ideal. However, people are corrupt, especially those with unlimited wealth and power; and all centralized governments have proven to become oppressive, to the detriment of families, human lives, individual rights and liberties, Christianity, and justice. All that God commands, Satan rejects. Globalism is disobedient to the dispersion command. The New World Order defies God’s order for nations and attempts to rebuild the Tower of Babel.

Globalism is also anti-American. America was founded on Christianity, on the belief that all people are equal, that they have God-endowed rights and liberties, and that government exists to secure those rights, not to take them away. A global government will contradict constitutional principles and reject American values (the U.N. Charter withdraws rights when they conflict with a U.N. purpose). The United States (particularly American nationalism and constitutionalism) and the Church (biblical Christianity) are the two remaining roadblocks to the New World Order. All globalist efforts will be aimed at compromising them by deception, distraction, or destruction. It is vital that God’s people understand what is happening and stand firm against the schemes of the devil.
